**To Whom It May Concern:**

**My name is George Tsakonas, in 1996 at the age of 24 I was diagnosed with Multiple Sclerosis. Since my progression was quite rapid, I have no mobility in my lower limbs and rely on the use of a power wheelchair to continue with my everyday life. For the past 10 years my family and I have been able to get around places that would otherwise be very difficult to get to with the help of my wheelchair lift in our 12 year old van. About 4 months ago our lift broke down and we have since been renting a manual ramp which my wife has been using to load the wheelchair into and out of the van. At the same time my wife would be helping me to transfer into the vehicle by lifting my legs into the van.**

**As much as we have prolonged the purchase of a newer vehicle because we simply could not afford it, we have no choice now but to buy an adapted van. Due to the severity of my MS this purchase would make it easier for me to get into the van without transferring from my wheelchair. Also less burdening my wife with helping me get myself and my legs into the vehicle.**

**On behalf of my wife and I, we authorize The Agios Petros Kinourias Social club and the Management of Flipper's Fish House to collect donations through fundraising that would go directly to the purchase of our adapted vehicle.**
